Coomes Center Summer Camp Junior Counselor Program

Objective of the Junior Counselor Program

The Junior Counselor Program has been developed to allow youth ages 13-15 to gain valuable leadership skills and to develop potential future Camp Counselors for Abingdon Parks & Recreation camp programs. Junior Counselors will work together with Camp Counselors to ensure summer camp remains a safe and supportive environment and to provide a fun, positive experience for all campers. **hours can be counted toward Washington County Community Scholars.

I. Candidate Qualifications

- A. All eligible participants will be at least 13 years of age on or before the first day of camp, and not older than 15 years of age. Those who do not meet specified age requirements will not be eligible for participation during the current summer season.
- B. Candidates must submit an application, two non-family references, and be willing to undergo an interview process.
- C. Candidates must demonstrate a high level of responsibility, maturity, enthusiasm, and reliability. Behavior MUST comply with the Junior Counselor Code of Conduct in order to remain in the program.
- D. A minimum of 3 full weeks of participation in the program is required.
- E. Limit 6 Junior Counselors per week for the summer season.

II. Application Process

There is an application process to ensure the Junior Counselors have the desire to participate fully and be a positive role model for the campers during the program. In addition to the application, a brief interview will be scheduled for each applicant.

- A. Interested participants must submit an application form and two non-family references to the Coomes Center by May 21, 2020. Applicant interviews will be scheduled for late May 2020. No applications will be accepted after May 22, 2020.
- B. Interviews will be conducted by the Summer Camp Coordinators of Parks & Recreation staff who will also serve as the selection committee.
- C. All applicants will be notified by phone whether or not they have been selected for the Junior Counselor program prior to the start of summer camp. The Abingdon Parks & Recreation Department reserves the right to reject an applicant or limit the number of applicants based on the camp program needs.
- D. All selected Junior Counselors will be expected to follow the Code of Conduct (attached), any offenses are subject to suspension or dismissal from the program.

III. Job Description and Duties

As a Junior Counselor you will work together with Camp Counselors to provide a fun, safe, and supportive camp environment and positive experiences to campers. You will be assigned a Camp Counselor to work with and will report to the camp coordinator and/or their supervisor. Duties:

- A. Adhere to camp rules and policies and Junior Counselor responsibilities
- B. Assist the Camp Coordinator and Camp Counselors with supervision of campers. Junior Counselors are not permitted to supervise campers alone, discipline campers, or administer first aid or medications.
- C. Assist Camp Coordinator and Camp Counselors with camp games and activities, including setup of games and activities, distribution of arts and crafts items and snacks, organization of camp areas, cleanup, bathroom breaks, etc.
- D. Report on program and camper issues to assigned Camp Counselor and/or Camp Coordinator

IV. Training

Once selected and registered for the program, Junior Counselors will be required to attend a Junior Counselor orientation meeting which will outline the guidelines and expectations of the program. Junior Counselors will also be expected to attend training as determined by the supervisor. Failure to attend the orientation and/or training will result in withdrawal from the Junior Counselor program.

V. Responsibilities

Junior Counselors will be expected to follow all camp rules and policies. The following is a list of responsibilities for Junior Counselors:

- A. Show up on time and appropriately dressed
- B. Come each day with a positive attitude
- C. Respect supervisors, fellow Junior Counselors, campers, parents, and the public
- D. Listen and follow instructions
- E. Participate in camp activities
- F. Do not use inappropriate language
- G. Be a positive role model for campers
- H. Be flexible and willing to help out wherever needed

VI. Disciplinary Procedures

As a Junior Counselor you will be held to a high standard. Campers will look up to you as a role model, and therefore any rule violations within the program will be taken very seriously. Based on the severity of the infraction, rule violations may result in a verbal warning, written warning, parent conference, or dismissal from the Junior Counselor program. Repeated rule violations will result in dismissal from the program without refund at the fitness coordinator's discretion.

VII. Financial Obligations and Requirements

Once selected for the Junior Counselor program you will be able to register for the sessions determined by the camp fitness coordinator at the reduced cost*. The cost of the Junior Program counselor is \$60 per week for members and \$75 per week for nonmembers. All Junior Counselors will receive two camp shirts. Camp shirts MUST be worn on field trip days. *Junior Counselors will not be eligible for partial week registrations.
